Section 7(1)(b) of FOIA provided that "private information" is exempt from disclosure. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when complied without possibility of attribution to any person." 5ILCS 140/2(c-5). Consequently, certain unique identifiers have been redacted from the records being provided.

Section 7(1)(c) of FOIA provides that, "[p]ersonal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion per person privacy" is exempt from disclosure. Consequently, a birthdate and other personal information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy, including a victim's name and identifying information, and the race of an individual, have been redacted from the records being provided.

Pursuant to Section 9 of the FOIA, 5 ILCS 140/9, I am required to advise you that I, the undersigned Freedom of Information Officer, reviewed and in consultation with an attorney for the Village, made the foregoing determination to deny a portion of your FOIA Request as indicated. Should you believe that this Response constitutes an improper denial of your request, you may appeal such by filing a request for review within sixty (60) days of the date of this letter with the Public Access Counselor of the Illinois Attorney General's Office, Public Access Bureau, 500 South Second Street, Springfield, Illinois 62706; telephone 1-887-299-FOIA; e-mail: publicaccess@atg.state.il.us. You may also have a right of judicial review of the denial under Section 11 of FOIA, 5 ILCS 140/11.

Report Narrative

On 11/29/2015 at approximately 1430 hours, R/O was dispatched to A&E Performance located at 588 Meyer Road for the report of a theft.

Upon arrival, R/O met with owner Frangos, Constantine (Gus) M/W [REDACTED] related that he had been on vacation in Greece for approximately a month and a half. While on vacation, his wife Frangos, Diane F/W [REDACTED] was supposed to take care of the business and pay any bills. He returned on Monday and came back to his shop. Gus discovered that no bills had been paid and an eviction notice was on the door of the business. Diane had not paid the owner. Gus also discovered that a Snap-On diagnostic scanner had been taken while he was in Greece. Gus related that the scanner is worth approximately \$4,500 and knows Diane took it. Gus related that Diane is addicted to crack cocaine and will steal items from the shop, pawn them and use the money for drugs. Gus stated that Diane has done this in the past because she has full access to the shop. Gus texted Diane regarding the scanner and she replied that she still had it in her possession. Gus contacted his son-in law who went to pick up the scanner from Diane's mothers house at an unknown location in Schiller Park. Gus related that they no longer live together and he is in contact with a lawyer for a future divorce. Gus related that he has had issues with Diane for the last 4-5 years and it has continued to get worse. Gus fears that Diane is going to steal more items from the shop due to having keys or may damage the shop. Diane also has keys for their vehicles. Diane has threatened that she will take the vehicles so Gus has nothing left. The son-in law arrived on scene and Gus confirmed that the scanner was returned in working order.

While on scene with Gus, Diane repeatedly called Gus and texted him using profanity and was sending nude photographs of herself to upset him.

R/O advised Gus that he could change the locks on the business and he related that he would do so as soon as possible. Gus also related that he did not want Diane charged and would not sign complaints.

Report Narrative

On 12/02/2015, R/O received a voicemail from Frangos requesting that R/O return to 588 Meyer Road regarding the prior incident.

Upon arrival, Frangos notified R/O that his landlord claimed he never received a rent payment for October 2015. Frangos related that he had gotten a \$500 Chase Bank cashiers check for rent. On the above mentioned date, Frangos went to the Chase Bank located at 123 W Main Street and the staff related that the cashiers check had been cashed and signed with his name. Frangos was provided with a copy of the signed check and believes that his wife Frangos, Diane fraudulently signed his name to obtain the \$500.00. Gus did not want to sign complaints against Diane and only wanted this incident documented in case of any future problems.
