These are all of the documents that can be discovered responsive to your request.


Section 7(1)(b) of FOIA provided that "private information" is exempt from disclosure. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when complied without possibility of attribution to any person." 5ILCS 140/2(c-5). Consequently, certain unique identifiers have been redacted from the records being provided.

Section 7(1)(c) of FOIA provides that, "[p]ersonal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion per person privacy" is exempt from disclosure. Consequently, a birthdate and other personal information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy, including a victim's name and identifying information, and the race of an individual, have been redacted from the records being provided.

Pursuant to Section 9 of the FOIA, 5 ILCS 140/9, I am required to advise you that I, the undersigned Freedom of Information Officer, reviewed and in consultation with an attorney for the Village, made the foregoing determination to deny a portion of your FOIA Request as indicated. Should you believe that this Response constitutes an improper denial of your request, you may appeal such by filing a request for review within sixty (60) days of the date of this letter with the Public Access Counselor of the Illinois Attorney General's Office, Public Access Bureau, 500 South Second Street, Springfield, Illinois 62706; telephone 1-887-299-FOIA; e-mail: [publicaccess@atg.state.il.us](mailto:publicaccess@atg.state.il.us). You may also have a right of judicial review of the denial under Section 11 of FOIA, 5 ILCS 140/11.

## Report Narrative

ON 9/29/16 AT APPROXIMATELY 1814 HOURS R/O RESPONDED TO THE PARKING LOT OF 145 E GRAND FOR THE REPORT OF A BURGLARY TO MOTOR VEHICLES. UPON ARRIVAL R/O SPOKE WITH COMPLAINANTS PALAZZOLO, ANGELA A F/W [REDACTED] AND DIMITRAKOS, JOANNE B F/W [REDACTED] WHO RELATED TO R/O IN SUMMARY:

ON 9/29/16 AT APPROXIMATELY 1700 HOURS BOTH COMPLAINTS PARKED THEIR VEHICLES IL REG [REDACTED] (JOANNE'S VEHICLE) AND IL REG [REDACTED] (ANGELA'S VEHICLE) IN THE PARKING LOT OF ST. CHARLES BORROMEIO CATHOLIC CHURCH. THE PARKING LOT IS LOCATED BEHIND THE CHURCH. THE WOMEN ENTERED THE BUILDING AND WHEN THEY RETURNED TO THEIR VEHICLES AT APPROXIMATELY 1805 HOURS THEY NOTICED DAMAGED WINDOWS TO BOTH THEIR VEHICLES AND THEIR PURSES HAD BEEN STOLEN.

ANGELA'S VEHICLE A SILVER IN COLOR 2012 MERCEDES-BENZ ML 350 HAD HER DRIVER'S SIDE WINDOW BROKEN. SHE STATED HER PURSE WHICH SHE PLACED IN THE BACK SEAT OF THE VEHICLE WAS STOLEN AS WELL AS A CARRYALL TYPE BAG FROM THE FRONT PASSENGER SEAT. NO OTHER PROPERTY WAS TAKEN FROM THE VEHICLE. ANGELA HAD HER WALLET ON HER PERSON.

JOANNE'S VEHICLE A BLACK IN COLOR 2010 CADILLAC ESCALADE HAD IT'S REAR RIGHT PASSENGER WINDOW BROKEN AND HER BLUE AND GOLD TED BAKER PURSE WAS STOLEN FROM THE REAR RIGHT PASSENGER SEAT OF THE VEHICLE. PER JOANNE, HER PURSE CONTAINED HER WALLET DESCRIBED AS A BLACK KATE SPADE WALLET WHICH CONTAINED HER DRIVER'S LICENSE, 3 DEBIT CARDS, AND 2 CREDIT CARDS.

COMPLAINANTS DO NOT KNOW WHO MAY HAVE BROKEN INTO THEIR VEHICLES. BYSTANDERS ON SCENE STATED THEY DID NOT WITNESS THE INCIDENT TAKE PLACE. THERE ARE NO CAMERAS FACING THE PARKING THE LOT OF ST. CHARLES BORROMEIO CATHOLIC CHURCH.

R/O ADVISED JOANNE TO CANCEL HER DEBIT AND CREDIT CARDS AS SOON AS POSSIBLE.

R/O ADVISED BOTH COMPLAINANTS TO CALL THEIR INSURANCE COMPANIES TO REPORT THE DAMAGE TO THEIR VEHICLES.

R/O TOOK PICTURES OF JOANNE'S VEHICLE. PRIOR TO R/O'S ARRIVAL STAFF FROM THE CHURCH HAD CLEARED THE GLASS FROM ANGELA'S VEHICLE HOWEVER ANGELA TOOK PICTURES OF THE DAMAGE PRIOR TO R/O'S ARRIVAL WHICH SHE GAVE TO R/O.

PICTURES OF THE DAMAGE TO BOTH VEHICLES HAVE BEEN SUBMITTED IN TO EVIDENCE.

R/O ADVISED BOTH COMPLAINANTS TO RECONTACT POLICE AND OR R/O IF THEY HAVE FURTHER INFORMATION.

ON 10/4/2016 AT APPROXIMATELY 2215 HOURS R/O SPOKE WITH COMPLAINANT DIMITRAKOS, JOANNE F/W [REDACTED] IN REGARDS TO THE BURGLARY TO MOTOR VEHICLE. SHE STATED TO R/O IN SUMMARY:

ON 9/30/16 DIMITRAKOS WENT TO HER BANK (MB FINANCIAL) LOCATED AT 1400 SIXTEENTH ST, OAKBROOK, IL 60523 TO SPEAK WITH A REPRESENTATIVE ABOUT FRAUDULENT ACTIVITY ON HER ACCOUNT AFTER HER PURSE CONTAINING HER INFORMATION WAS STOLEN FROM HER CAR. PER DIMITRAKOS, SHE NOTICED APPROXIMATELY \$5,000 HAD BEEN TAKEN FROM HER PERSONAL CHECKING ACCOUNT.

DIMITRAKOS STATED UPON SPEAKING WITH HEMA DESAI, WHO IS A BANKING SPECIALIST FOR MB FINANCIAL, THEY WERE ABLE TO LOCATE 5 CHECKS IN TOTAL THAT WERE CASHED FROM DIMITRAKOS ACCOUNT. THE SUSPECTS IN QUESTION WERE WRITING CHECKS THEY HAD OBTAINED FROM OTHER VICTIMS IN DIMITRAKOS NAME. THEY WOULD THEN USE DIMITRAKOS DRIVER'S LICENSE AT THE KIOSK OF SEVERAL MB FINANCIAL BANK BRANCHES TO OBTAIN THE MONEY FROM THEY CHECKS THEY HAD WRITTEN. DIMITRAKOS OBTAINED COPIES OF 5 CHECKS WRITTEN IN HER NAME THAT WERE ALL CASHED ON 9/30/16 BETWEEN THE HOURS OF 1212 AND 1600.
