Dear Ms. Dietrich:

I am pleased to help you with your November 1, 2016 Freedom of Information Act ("FOIA"). Your request was received by the Village of Bensenville on November 8, 2016. You requested copies of the items indicated below:

"Police report for Ramiro Ta;avera."

After a search of Village files, the following documents are enclosed to fulfill your request:

- 1) Village of Bensenville Arrest Report No. BV15009422.1. (3 pgs.)

These are all of the documents that can be discovered responsive to your request.

Section 7(1)(b) of FOIA provided that "private information" is exempt from disclosure. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when complied without possibility of attribution to any person." 5ILCS 140/2(c-5). Consequently, certain unique identifiers have been redacted from the records being provided.

Section 7(1)(c) of FOIA provides that, "[p]ersonal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion per person privacy" is exempt from disclosure. Consequently, a birthdate and other personal information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy, including a victim's name and identifying information, and the race of an individual, have been redacted from the records being provided.

Pursuant to Section 9 of the FOIA, 5 ILCS 140/9, I am required to advise you that I, the undersigned Freedom of Information Officer, reviewed and in consultation with an attorney for the Village, made the foregoing determination to deny a portion of your FOIA Request as indicated. Should you believe that this Response constitutes an improper denial of your request, you may appeal such by filing a request for review within sixty (60) days of the date of this letter with the Public Access Counselor of the Illinois Attorney General's Office, Public Access Bureau, 500 South Second Street, Springfield, Illinois 62706; telephone 1-887-299-FOIA; e-mail: publicaccess@atg.state.il.us. You may also have a right of judicial review of the denial under Section 11 of FOIA, 5 ILCS 140/11.

Report Narrative **ON 090215 AT APPROXIMATELY 2045 HRS RO AND OFCS LINKOWSKI 520 AND VALOIS 562 RESPONDED TO THE REPORT OF A BATTERY AT REDMOND PARK- DISPATCH ADVISED THAT THE OFFENDER HAD LEFT THE SCENE IN A WHITE VEHICLE. CALLER/ VICTIM RAMIRO TALAVERA MW [REDACTED] STATED THE FOLLOWING TO RO:**

RAMIRO IS A REFEREE AND WAS CALLING A MATCH FOR A SOCCER ORGANIZATION. PLAYER/ OFFENDER ALEXANDRU G BUDAC MW [REDACTED] WAS ANGRY AT HOW THE GAME WAS BEING CALLED BY RAMIRO; ALEXANDRU SHOUTED AT RAMIRO "YOU'RE A FUCKING IDIOT!" AND THEN RECEIVED A RED CARD FOR COMPOSURE AT WHICH TIME HE BECAME MORE ANGRY. RAMIRO STATED ALEXANDRU GRABBED HIM BY THE NECK AT WHICH TIME ANOTHER PLAYER PUSHED ALEXANDRU OFF RAMIRO- ALEXANDRU WAS THEN EJECTED FROM THE GAME. ALEXANDRU PUNCHED RAMIRO ON THE LEFT SIDE OF THE FACE NEAR WHERE THE JAW MEETS THE EAR. ALEXANDRU AND ANOTHER UNKNOWN MALE THEN LEFT THE FIELD.

RAMIRO LOOKED UPWARDS AND POINTED TO PATCHES OF SKIN WHERE THE CONTACT WAS MADE. RO TOOK PHOTOS OF RAMIRO WHICH WERE PLACED INTO EVIDENCE. RAMIRO REFUSED MEDICS AT THE SCENE.

OFCS LINKOWSKI 520 AND VALOIS 562 SPOKE WITH WITNESSES JANUSZ BOSOWSKI MW [REDACTED], GOALIE FOR THE OPPOSING TEAM, AND RENATA BECHTOLDT FW 010874, COMMISSIONER FOR THE ILLINOIS SOCCER ASSOCIATION. BOTH WITNESS STATED ALEXANDRU WAS ISSUED A YELLOW CARD; ALEXANDRU PUSHED RAMIRO AND WAS THEN EJECTED AT WHICH TIME HE GRABBED RAMIRO BY THE NECK AND PUNCHED HIM.

OFC LINKOWSKI 520 SPOKE WITH OTHER PLAYERS FROM ALEXANDRU'S TEAM THAT WERE ABLE TO CALL ALEXANDRU BACK TO THE SCENE. ALEXANDRU EXITED THE PASSENGER SIDE OF A WHITE HATCHBACK TO SPEAK WITH RO. ALEXANDRU ADMITTED TO BEING ANGRY AND ATTACKING THE REFEREE. ALEXANDRU WAS ARRESTED AND TRANSPORTED TO THIS PD FOR PROCESSING BY RO.

1 COUNT OF MISDEMEANOR BATTERY ON FORM 325653 WAS PREPARED AGAINST ALEXANDRU. AT APPROXIMATELY 2200 HRS ALEXANDRU WAS RELEASED FROM THIS PD BY RO AFTER BEING ISSUED AN IBOND ON BB305555.
