After a search of Village files, the following documents are enclosed to fulfill your request:

- 1) Village of Bensenville Non Crime/Other Report No. BV16011584.1. (2 pgs.)

These are all of the documents that can be discovered responsive to your request.

Section 7(1)(b) of FOIA provided that "private information" is exempt from disclosure. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when complied without possibility of attribution to any person." 5ILCS 140/2(c-5). Consequently, certain unique identifiers have been redacted from the records being provided.

Section 7(1)(c) of FOIA provides that, "[p]ersonal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion per person privacy" is exempt from disclosure. Consequently, a birthdate and other personal information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy, including a victim's name and identifying information, and the race of an individual, have been redacted from the records being provided.

Pursuant to Section 9 of the FOIA, 5 ILCS 140/9, I am required to advise you that I, the undersigned Freedom of Information Officer, reviewed and in consultation with an attorney for the Village, made the foregoing determination to deny a portion of your FOIA Request as indicated. Should you believe that this Response constitutes an improper denial of your request, you may appeal such by filing a request for review within sixty (60) days of the date of this letter with the Public Access Counselor of the Illinois Attorney General's Office, Public Access Bureau, 500 South Second Street, Springfield, Illinois 62706; telephone 1-887-299-FOIA; e-mail: publicaccess@atg.state.il.us. You may also have a right of judicial review of the denial under Section 11 of FOIA, 5 ILCS 140/11.

Report Narrative

On 11/10/2016 at approximately 1610 hours, R/O was dispatched to the Bensenville Police Department lobby for a citizen assist.

Upon arrival, R/O met with [REDACTED] F/W [REDACTED] who related that she was seeking advice regarding her husband's aunt Davis, Silveria F/W [REDACTED] has had financial Power of Attorney for Davis since 2014. Garcia related that Davis is temporarily staying at [REDACTED] at [REDACTED]. Davis told [REDACTED] that her granddaughter West, Stephanie F/W [REDACTED] had moved in to the [REDACTED] residence without permission. [REDACTED] related that West has had keys to the residence for some time. Davis told [REDACTED] that she wanted West out of the house. R/O and A/O Kotlewski #561 arrived at [REDACTED] to speak with Davis. Davis related that she did not want West at the house and she did not have permission to be there. Davis suffers from dementia.

While speaking with Davis, Bridgeway Senior Living Social Worker Castaneda, Elizabeth approached R/O and A/O regarding [REDACTED] and Davis. Castaneda advised that Davis is not of sound mind, has dementia and cannot make any decisions for herself. Bridgeway had been contacted on 11/10/2016 by the Department of Aging and advised that an elder abuse investigation was being opened up against [REDACTED] for financial exploitation. Staff also told [REDACTED] that she is not allowed at [REDACTED]. Castaneda related that the Health Care Power of Attorney is West, Stephanie and provided R/O with the current Power of Attorney paperwork.

R/O made contact with West. West advised that her grandmother (Davis) has been in and out of the hospital since July 2016. Davis' only son West, Clint resides in Texas and cannot be there for his mother so West began taking care of her and her house. West obtained Health Care Power of Attorney and is in contact with a lawyer. West is working on becoming guardian of Davis due to her declining mental state. West related that she discovered a will that was written by [REDACTED] which states that after Davis is deceased, all money and property will go to [REDACTED]. West is concerned because [REDACTED] owns 6 propertys and rents them out. West fears that [REDACTED] will clean out the [REDACTED] residence and rent it out. West related that [REDACTED] has not been around for Davis in years and all of a sudden has started to act like she has been caring for Davis. West also discovered that [REDACTED] has been cashing Davis' social security checks monthly but cannot account for the money. West reported that information to the Department of Aging who advised her that after numerous unsuccessful attempts to contact [REDACTED], a financial exploitation case is going to be begin on 11/14/2016. Department of Aging related that [REDACTED] will not answer the phone nor provide any documentation of finances.

A copy of the health care power of attorney is attached to this report.
