I am pleased to help you with your November 15, 2016 Commercial Freedom of Information Act ("FOIA"). Your request was received by the Village of Bensenville on November 15, 2016. You requested copies of the items indicated below:

These are all of the documents that can be discovered responsive to your request.

Section 7(1)(b) of FOIA provided that "private information" is exempt from disclosure. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when complied without possibility of attribution to any person." 5ILCS 140/2(c-5). Consequently, certain unique identifiers have been redacted from the records being provided.

Section 7(1)(c) of FOIA provides that, "[p]ersonal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion per person privacy" is exempt from disclosure. Consequently, a birthdate and other personal information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy, including a victim's name and identifying information, and the race of an individual, have been redacted from the records being provided.

Pursuant to Section 9 of the FOIA, 5 ILCS 140/9, I am required to advise you that I, the undersigned Freedom of Information Officer, reviewed and in consultation with an attorney for the Village, made the foregoing determination to deny a portion of your FOIA Request as indicated. Should you believe that this Response constitutes an improper denial of your request, you may appeal such by filing a request for review within sixty (60) days of the date of this letter with the Public Access Counselor of the Illinois Attorney General's Office, Public Access Bureau, 500 South Second Street, Springfield, Illinois 62706; telephone 1-887-299-FOIA; e-mail: [publicaccess@atg.state.il.us](mailto:publicaccess@atg.state.il.us). You may also have a right of judicial review of the denial under Section 11 of FOIA, 5 ILCS 140/11.

Report Narrative: AT 2355 HOURS, 3/31/15, RO WAS NOTIFIED OF A CRASHED MOTOR VEHICLE AT THE INTERSECTION OF IRVING PARK ROAD AND CHURCH ROAD. RO ALONG WITH OFC CHA, OFC HERRERA, OFC GUEST, OFC LABUZ ARRIVED AND OBSERVED AN UNOCCUPIED GREY 2003 HUMMER H2 BEARING IL REGISTRATION [REDACTED] CRASHED ON THE NORTHERN SIDEWALK OF IRVING PARK ROAD. BENSENVILLE OFFICERS OBSERVED A MALE, LATER IDENTIFIED AS SEBASTIAN FILLMAN M/W [REDACTED], WALKING WESTBOUND ON IRVING PARK ROAD AT THE INTERSECTION WITH CHURCH ROAD. OFC HERRERA ARRIVED AND OBSERVED FILLMAN WHO WAS TALKING ON HIS PHONE AND THEN BEGAN RAPIDLY WALKING ONCE OFC HERRERA STOPPED HIS PATROL CAR. OFC HERRERA OBSERVED FILLMAN WAS HOLDING CAR KEYS IN HIS LEFT HAND AND SAW PICTURES OF THE CRASHED 2003 HUMMER ON FILLMANS PHONE. OFC HERRERA ASKED FILLMAN WHO THE 2003 HUMMER BELONGED TO AND IF IT WAS HIS CAR AND FILLMAN DENIED ANY KNOWLEDGE OF THE HUMMER. OFC LABUZ RAN THE LICENSE PLATE OF THE 2003 HUMMER THROUGH THE SECRETARY OF STATES OFFICE WHICH SHOWED THE REGISTERED OWNER WAS SEBASTIAN FILLMAN AND THEY KEYS FILLMAN WAS HOLDING BELONGED TO THE 2003 HUMMER. OFC LABUZ CONDUCTED AND INVENTORY OF THE VEHICLE AND FOUND AN EMPTY BEER BOTTLE IN THE FRONT PASSENGER SEAT WHICH WAS PHOTOGRAPHED AND PLACED INTO EVIDENCE. RO OBSERVED FILLMAN WITH GLASSY AND WATERY EYES, HIS SPEECH WAS HEAVILY SLURRED, AND RO WAS ABLE TO SMELL A STRONG ODOR OF AN ALCOHOLIC BEVERAGE. FILLMAN WAS VERY UNEASY ON HIS FEET AND WAS UNABLE TO MAINTAIN BALANCE WHILE STANDING SO HE WAS INSTRUCTED TO SIT ON A LEDGE.

RO ASKED FILLMAN WHERE HE WAS COMING FROM AND WHERE HE LIVED AND FILLMAN STATED HE WAS AT HIS FRIENDS GARAGE AT AN UNKNOWN ADDRESS IN BENSENVILLE DRINKING AND BEGAN WALKING DOWN IRVING PARK ROAD. FILLMAN BECAME BELIGERANT AND IRATE WHEN BEING ASKED QUESTIONS AND SAID HE NO LONGER COULD SPEAK ENGLISH AND ONLY KNEW POLISH. OFC MARKIEWICZ #408 FROM ADDISON POLICE DEPARTMENT ARRIVED ON SCENE TO SPEAK TO FILLMAN IN POLISH. OFC MARKIEWICZ RELAYED THAT FILLMAN STATED HE WAS DRINKING IN A FRIENDS GARAGE IN BENSENVILLE AND THAT HIS FRIEND BEGAN DRIVING HIS CAR WHILE FILLMAN SAT IN THE PASSENGER SEAT WHEN THE VEHICLE CRASHED. FILLMAN WAS ASKED FOR THE NAME OF HIS FRIEND AND HE SAID IT WAS THE SAME AS OFC MARKIEWICZ AND WAS UNABLE TO PROVIDE ANY DETAILS FOR HIS FRIEND. RO ATTEMPTED TO CONDUCT STANDARDIZED FIELD SOBRIETY TESTS ON FILLMAN WITH THE AIDE OF OFC MARKIEWICZ BUT FILLMAN REFUSED ALL TESTS.

FILLMAN WAS PLACED UNDER ARREST FOR DUI AND PLACED IN THE REAR SEAT OF SQUAD 301 AND TRANSPORTED TO BENSENVILLE PD BY OFC CHA. FILLMANS VEHICLE WAS REMOVED FROM THE SCENE BY TOMATOWS TOWING. WHEN FILLMAN ARRIVED AT BENSENVILLE PD HE IMMEDIATELY LAYED ON THE GROUND AND STARTED SCREAMING DOCTOR AND DEMANDED A POLISH TRANSLATOR WHILE CONTINUING TO CARRY ON CONVERSATIONS IN ENGLISH. FILLMAN THEN PRETENDED TO BE UNCONSCIOUS AND REFUSED TO WALK SO HE WAS CARRIED INTO THE BOOKING ROOM. AT 0042 HOURS, 4/1/15, RO READ FILLMAN THE WARNING TO MOTORIST AND WHILE RO WAS READING FILLMAN CONSTANTLY SCREAMED "NO" DURING THE DURATION. AT 0107 HOURS, FILLMAN WAS GIVEN THE OPPORTUNITY TO PROVIDE A BREATH SAMPLE INTO THE BREATHALIZER AND FILLMAN REFUSED. FILLMAN WAS THEN PLACED INTO CELL #3.

AT 0130 HOURS, FILLMAN WAS OBSERVED VIA CAMERA ATTEMPTING TO HANG HIMSELF WITH A BLANKET THAT HE TIED AROUND THE CELL BARS IN CELL #3. RO, OFC HERRERA, OFC LABUZ, AND OFC GUEST INSTRUCTED FILLMAN TO EXIT THE CELL SO HE COULD BE MOVED TO AN ADJACENT CELL WITH NO BLANKET. FILLMAN WAS PHYSICALLY REMOVED FROM THE CELL AND THEN HE WENT INTO A CORNER OF THE SHOWER WHERE HE BEGAN TO YELL AT BENSENVILLE OFFICERS AND SAT ON THE FLOOR. FILLMAN WAS INSTRUCTED BY OFC HERRERA TO GET UP AND GO INTO CELL #4 OR HE WOULD BE CHARGED WITH RESISTING A PEACE OFFICER. FILLMAN STOOD UP AND HAD TO BE ESCORTED BY BENSENVILLE OFFICERS INTO CELL 4. ONCE IN CELL #4 FILLMAN RUSHED OUT OF THE CELL AND ATTEMPTED TO GRAB RO. OFC LABUZ ATTEMPTED TO DRIVE STUN FILLMAN WITH A TASER AND FILLMAN BEGAN
