I am pleased to help you with your November 21, 2016 Freedom of Information Act ("FOIA"). Your request was received by the Village of Bensenville on November 21 2016. You requested copies of the items indicated below:

After a search of Village files, the following documents are enclosed to fulfill your request:

- 1) Village of Bensenville Non Crime/Other Report No. BV16011392.1. (3 pgs.)

These are all of the documents that can be discovered responsive to your request.

Section 7(1)(b) of FOIA provided that "private information" is exempt from disclosure. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when complied without possibility of attribution to any person." 5ILCS 140/2(c-5). Consequently, certain unique identifiers have been redacted from the records being provided.

Section 7(1)(c) of FOIA provides that, "[p]ersonal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion per person privacy" is exempt from disclosure. Consequently, a birthdate and other personal information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy, including a victim's name and identifying information, and the race of an individual, have been redacted from the records being provided.

Pursuant to Section 9 of the FOIA, 5 ILCS 140/9, I am required to advise you that I, the undersigned Freedom of Information Officer, reviewed and in consultation with an attorney for the Village, made the foregoing determination to deny a portion of your FOIA Request as indicated. Should you believe that this Response constitutes an improper denial of your request, you may appeal such by filing a request for review within sixty (60) days of the date of this letter with the Public Access Counselor of the Illinois Attorney General's Office, Public Access Bureau, 500 South Second Street, Springfield, Illinois 62706; telephone 1-887-299-FOIA; e-mail: publicaccess@atg.state.il.us. You may also have a right of judicial review of the denial under Section 11 of FOIA, 5 ILCS 140/11.

Report Narrative

ON 11/5/2016 AT APPROXIMATELY 1818 HOURS R/O RESPONDED TO THE POLICE STATION LOBBY FOR THE CITIZEN ASSIST. UPON ARRIVAL R/O SPOKE WITH COMPLAINANTS BUGAJNY, WALTER S M/W [REDACTED] AND HIS WIFE [REDACTED], [REDACTED] F/W [REDACTED] WHO STATED TO R/O IN SUMMARY AND NOT VERBATIM:

ON 10/31/2016 AT APPROXIMATELY 1000 HOURS [REDACTED] BROTHER JOHNSON, RONALD M/W [REDACTED] WENT TO BRIDGEWAY NURSING HOME LOCATED AT 111 E WASHINGTON, BENSENVILLE, IL 60106 TO VISIT HIS PARENTS JOHNSON, NELSON M/W [REDACTED] AND JOHNSON, ERIKA, F/W [REDACTED]. PER [REDACTED], AFTER RONALD VISITED THE NURSING HOME SHE RECEIVED A CALL FROM BRIDGEWAY STAFF INFORMING HER RONALD HAD AN OUTBURST TOWARD THE STAFF WHILE VISITING ERIKA AND NELSON.

[REDACTED] STATED DUE TO AN ORDER OF PROTECTION FOR HER PARENTS, ERIKA AND NELSON, AGAINST RONALD, HE IS ALLOWED TO VISIT THEM BUT NOT TAKE THEM FROM THE PREMISES OF THE NURSING HOME. [REDACTED] FURTHER STATED THE STAFF TOLD HER RONALD ATTEMPTED TO TAKE ERIKA AND NELSON OUTSIDE OF THE FACILITY AND THE STAFF STOPPED HIM FROM DOING SO. AFTER THE STAFF STOPPED RONALD FROM REMOVING ERIKA AND NELSON FROM THE PREMISES HE BECAME IRATE AND BEGAN SHOUTING AT THE STAFF AND YELLED AT HIS PARENTS AS WELL.

WALTER STATED THE STAFF TOLD HIM THAT DURING RONALD'S OUTBURST HE THREATENED PHYSICAL VIOLENCE AGAINST STAFF MEMBERS. PER WALTER, STAFF MEMBERS DID NOT CONTACT POLICE TO REPORT THE INCIDENT.

[REDACTED] STATED THEY TOOK OUT AN ORDER OF PROTECTION AGAINST HIM FOR ERIKA AND NELSON DUE TO RONALD BEING NEGLECTFUL WHEN HE TAKES CARE OF THEM.

ORDER OF PROTECTION CASE # 160P30495 (JOHNSON, ERIKA).

PER [REDACTED], ERIKA AND NELSON HAVE BEEN IN THE NURSING HOME FOR APPROXIMATELY 6 MONTHS DUE TO ERIKA HAVING HEALTH ISSUES. [REDACTED] STATED NELSON WENT TO LIVE WITH HER DURING THIS TIME. [REDACTED] FURTHER STATED INCIDENTS INVOLVING HER BROTHER, RONALD, AND HER PARENTS, ERIKA AND NELSON, HAVE BEEN GOING ON FOR APPROXIMATELY 2 MONTHS.

PER [REDACTED], RONALD IS NOT ONLY NEGLECTFUL TOWARD ERIKA AND NELSON BUT HAS ALSO TAKEN FOOD AND CLOTHES FROM THEM AS WELL. [REDACTED] STATED THESE INCIDENTS HAVE NOT BEEN DOCUMENTED WITH BENSENVILLE POLICE NOR THE NURSING STAFF.

PER [REDACTED], SHE WANTED THE INCIDENT DOCUMENTED FOR COURT PURPOSES.

ON 11/5/2016 AT APPROXIMATELY 1935 HOURS R/O ATTEMPTED TO CONTACT KUEKING, MAGGIE F/W WHO IS A SOCIAL WORKER AT BRIDGEWAY TO INFORM HER OF THE SITUATION AND ALSO INFORM HER IF RONALD ACTS OUT AGAIN WHILE AT BRIDGEWAY TO CONTACT POLICE. R/O WAS UNABLE TO SPEAK WITH KUEKING DUE TO HER NOT BEING IN THE OFFICE. R/O LEFT A MESSAGE WITH STAFF MEMBER, VIDA.

R/O WILL ATTEMPT TO CONTACT KUEKING ON 11/7/2016 DURING NORMAL BUSINESS HOURS.
