These are all of the documents that can be discovered responsive to your request.


Section 7(1)(b) of FOIA provided that "private information" is exempt from disclosure. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when complied without possibility of attribution to any person." 5ILCS 140/2(c-5). Consequently, certain unique identifiers have been redacted from the records being provided.

Section 7(1)(c) of FOIA provides that, "[p]ersonal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion per person privacy" is exempt from disclosure. Consequently, a birthdate and other personal information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy, including a victim's name and identifying information, and the race of an individual, have been redacted from the records being provided.

Pursuant to Section 9 of the FOIA, 5 ILCS 140/9, I am required to advise you that I, the undersigned Freedom of Information Officer, reviewed and in consultation with an attorney for the Village, made the foregoing determination to deny a portion of your FOIA Request as indicated. Should you believe that this Response constitutes an improper denial of your request, you may appeal such by filing a request for review within sixty (60) days of the date of this letter with the Public Access Counselor of the Illinois Attorney General's Office, Public Access Bureau, 500 South Second Street, Springfield, Illinois 62706; telephone 1-887-299-FOIA; e-mail: [publicaccess@atg.state.il.us](mailto:publicaccess@atg.state.il.us). You may also have a right of judicial review of the denial under Section 11 of FOIA, 5 ILCS 140/11.

## Report Narrative

At approximately 1016 hours on 11/17/16 R/O was dispatched to Home Medical Express 621 N Route 83 for a suspicious incident report.

R/O arrived on scene and met with Beth Schieber f/w, owner of company, who related the following information in summary: On 11/16/16 and 11/17/16 she received two anonymous emails, from HMEconcernedspouse@mail.com, relating that Larry, one of their delivery drivers, is selling drugs out of the company vehicle. The email also related that Larry is stealing items, jewelry and prescription medications, and also selling them. Schieber related that Larry D Williams m/b [REDACTED] was hired on 09/30/2013 and has been working for Home Medical Express since then. Schieber related that Williams is often late to work and a few months ago one of Williams' patients reported that his watch was missing. Williams stated that he did not take the watch so the company replaced it. Schieber asked R/O that she would like the Bensenville Police Department to search the company van that Williams drives.

An inquiry through LEADS of Williams showed that his Illinois driver's license expired on 01/31/15. Schieber related that Williams starts his shift at 1100 hours. Schieber and her business partner [REDACTED] m/w [REDACTED] related that Williams had just arrived in the company van on the Southside of the building.

R/O and A/O Linkowski met Williams on the side of building. R/O asked Williams if he drove to Home Medical Express and he replied that he did. R/O asked Williams if he had a personal vehicle at Home Medical Express and he replied that he does not. R/O placed Williams under arrest for driving without a valid driver's license. R/O performed a search incident to arrest and found a small, clear bag with small yellow pills inside Williams' small right pants pocket. R/O asked what they were and Williams said they were sex pills. A/O Linkowski transported Williams and his property back to the Bensenville Police Department(BPD).

R/O obtained written consent to search a white Ford E-250 Super Duty bearing Illinois 1259428B truck plate from owners Schieber and [REDACTED] R/O searched said vehicle and located a blue backpack containing a plastic sandwich size bag with blue and orange pills, a Tmobile cellphone, garmin gps and 3 different apple Ipods. Schieber and [REDACTED] related that the cellphone is company owned and was provided to Williams. R/O transported the plastic bag with pills, cellphone, ipods and 2 additional cellphones to BPD. The blue backpack was left in the company vehicle.

Upon closer inspection of the small plastic bag with yellow pills found inside Williams' pants pocket at time of arrest, R/O observed the pills to be oval shaped, yellow with S 901 stamped on them. R/O searched drugs.com and identified the pills as Alprazolam 0.5 mg, which is a schedule 4 controlled substance. There were 20 Alprazolam pills inside the small bag. There were three different types of pills in the sandwich size bag. 17 diamond-like shaped, blue pills with pfizer stamped on one side and VGR100 on the back. R/O searched drugs.com and identified the pills as Viagra 100mg, which is available by prescription only. 31 oval shaped, orange pills with C20 stamped on one side. R/O searched drugs.com and identified the pills as Cialis 20 mg, which is available by prescription only. 2 yellow-orange, small circle shaped pills with bayer bayer stamped on one side and 20 on the back. R/O searched drugs.com and identified the pills as Levitra 20mg, which is available by prescription only. R/O took photographs of pills.

At R/O's request dispatch searched the ipod serial numbers through LEADS and none were reported stolen. R/O photographed the ipods, gps and cellphones. The ipods, gps and two cellphones were returned to Williams' property; the company Tmobile phone was returned to [REDACTED] at Home Medical Express.

R/O entered interview room #193, which is video and audio recorded, with Williams and read him his Miranda Warning from a preprinted form. Williams waived his Miranda Rights and agreed to speak to R/O. Williams related the following information in

## summary:

He has been working for Home Medical Express for approximately 3 years as a delivery driver. He delivers home medical equipment, such as oxygen tanks, to patients at home or medical facilities. Drivers are allowed to take company vehicles home, but leave them at the business if they are going to be off the following day. Williams currently has Tuesdays and Sundays off, so he took the company vehicle home Wednesday after his shift. R/O asked Williams what the pills were and he related that the blue ones were Viagra, the orange ones were Cialis and the small circle ones were Levitra. He said all the pills were sex pills. R/O asked Williams what the small yellow oval shaped pills stamped S 901 were and he replied that they were for his stomach. At first, Williams related they were for burning in his stomach, like anxiety for his stomach. R/O mentioned if they were for acid in his stomach and Williams replied yes for acid reflex.

At first, Williams related that he had prescriptions for all the pills and that his wife could bring them to the station. Later Williams related that he did not have prescriptions for the sex pills, but bought them on the West side. Williams related that he does have a prescription for the small yellow oval shaped pills stamped S 901. Williams related that he is prescribed 50 of those pills every 2 months and he takes 2 daily, after he eats. Williams related that the bottle costs \$70.00 and is prescribed them by his doctor located at 75th and Woodridge.

Williams related that some of his coworkers give him money for him to buy and bring them 2-3 bags of weed from the city. R/O told Williams that those pills are a generic form of Xanax. Williams then said that his coworker Willie, a big hispanic fat male with a long ponytail approximately 30 to 40 years of age, gave them to him to give to a girl just before the police arrived. Williams said that he does not know what those pills are, but in the past he has given them to the girl for Willie. Williams said that he does not receive payment and Willie probably has some sex thing going on with her because Williams has given Willie some Viagra in the past. R/O asked why earlier he said that the pills were for acid and that he was prescribed them. Williams replied that he was wrong about that. R/O asked Williams for Willie's information and he related that the pills were in his possession so he will take the charge. Williams related that he was not selling the pills.

R/O contacted felony screening and screened the case. Assistant State's Attorney JL approved one count of Possession of Controlled Substance class 4 Felony for possession of the Alprazolam pills found in Williams' pants pocket at time of arrest. No charges for pills found inside the backpack.

A/O Valois booked and processed Williams. R/O served Williams with complaint of one count of class 4 Felony Possession of Controlled Substance and one misdemeanor count of Driving with No Valid Driver's License. Officer Scanlan transported Williams to the Dupage County Jail and released him to the custody of DCCO Gruber #520.

R/O submitted the following items into evidence:
