Dear Mr. Kulesza :

I am pleased to help you with your November 22, 2016 Freedom of Information Act ("FOIA"). Your request was received by the Village of Bensenville on November 22 2016. You requested copies of the items indicated below:

*"Report No. BV16008242."*

After a search of Village files, the following documents are enclosed to fulfill your request:

- 1) Village of Bensenville Arrest Report No. BV16008242.1. (7 pgs.)
- 2) Village of Bensenville Follow-Up Report No. BV16008242.2. (1 pg.)

These are all of the documents that can be discovered responsive to your request.

Section 7(1)(b) of FOIA provided that "private information" is exempt from disclosure. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when complied without possibility of attribution to any person." 5ILCS 140/2(c-5). Consequently, certain unique identifiers have been redacted from the records being provided.

Section 7(1)(c) of FOIA provides that, "[p]ersonal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion per person privacy" is exempt from disclosure. Consequently, a birthdate and other personal information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy, including a victim's name and identifying information, and the race of an individual, have been redacted from the records being provided.

Pursuant to Section 9 of the FOIA, 5 ILCS 140/9, I am required to advise you that I, the undersigned Freedom of Information Officer, reviewed and in consultation with an attorney for the Village, made the foregoing determination to deny a portion of your FOIA Request as indicated. Should you believe that this Response constitutes an improper denial of your request, you may appeal such by filing a request for review within sixty (60) days of the date of this letter with the Public Access Counselor of the Illinois Attorney General's Office, Public Access Bureau, 500 South Second Street, Springfield, Illinois 62706; telephone 1-887-299-FOIA; e-mail: [publicaccess@atg.state.il.us](mailto:publicaccess@atg.state.il.us). You may also have a right of judicial review of the denial under Section 11 of FOIA, 5 ILCS 140/11.

Report Narrative

On 08/16/2016 at approximately 1848 hours, R/O was dispatched to the area of [REDACTED] for the report of two to three juveniles kicking a car and yelling at passing cars. The caller was reportedly a neighbor observing the incident.

Upon arrival, R/O and A/O Kotlewski #561 were searching the area but were unable to locate any juveniles in the area. Residents of [REDACTED] exited the house and began yelling at R/O and A/O about the juveniles who just left their house. The resident Randolph, Kimberly F/W [REDACTED] and her juvenile son (AB) did not call 911 and related that they took care of it themselves because "the police do not do anything." Randolph related that the suspect juveniles were last seen running north bound on Marshall Road.

Juvenile AB and his friend [REDACTED] M/W [REDACTED] showed R/O the car they were in at the time of the incident, which belongs to his parents [REDACTED]. The 09 Nissan bearing IL Reg [REDACTED] was parked on Hillside in front of [REDACTED]. R/O observed fresh damage on the hood which appeared to have been made by brass knuckles, a cracked front passenger side bumper and a dent in the rear passenger door. [REDACTED] provided the following information: [REDACTED] and AB were sitting in the car in the driveway when Juveniles RC and BV arrived on scene and were talking. Suddenly, RC and BV became upset and began yelling. Juveniles RC and BV began kicking and punching [REDACTED] car. [REDACTED] rolled the windows up. Both RC and BV were attempting to pull on the handles to get in the car and successfully opened the rear passenger side door. Juvenile AB and [REDACTED] related that Juvenile BV had brass knuckles and began punching the car, denting the hood. [REDACTED] drove away from the scene west bound on Hillside Drive and Juveniles RC and BV left the area in an unknown direction. [REDACTED] and Juvenile AB did not call 911 to alert police but were on the phone "Facetimeing" with Juvenile AB's mother Randolph. Randolph was on her way to the house after witnessing the incident via Facetime. [REDACTED] related that he would sign complaints if the offenders were located due to the damage on his parents car.

The juveniles were described as one wearing a white shirt with black pants and the other with black shirt and black pants. R/O and A/O began checking the surrounding area for Juveniles RC and BV. R/O arrived at Juvenile RC's residence at [REDACTED] and spoke with RC's mother, Vazquez Nelly who advised that RC was not home and would notify R/O if he returned home. Detective Ptak #532 arrived on scene.

After speaking with Vazquez, R/O observed two juveniles to the rear lot of [REDACTED] walking towards Stoneham and Franzen. The juveniles were matching the description provided by the witnesses/victim. R/O began walking south bound towards Stoneham in an attempt to confirm if they were the offenders. The two males looked at R/O and began running. R/O began to run after suspects who then fled in unknown direction. R/O advised assisting officers of the information and R/O and A/O's began checking the surrounding area, including the industrial area just north of the location. While looking in the area of Country Club Drive and Eagle Drive, R/O located the two suspect juveniles walking down Eagle Drive. Both juveniles stopped walking when R/O pulled up next to them near 795 Eagle Dr. A/O's arrived on scene. Detective Ptak arrived on scene who is a Juvenile Officer. Both Juveniles RC and BV stated that they were at Juvenile AB's house because Juvenile AB had robbed BV for \$10 worth of pot a couple weeks before. Juvenile RC said AB had also been talking a lot of shit. The brass knuckles were not found on either subject.

While on scene with the suspect juveniles, R/O spoke with original complainant Schmidt, Kimberly [REDACTED] who related that she had called 911. Schmidt saw a black car in the driveway at [REDACTED]. Juvenile AB got into the car and was sitting inside when two male juveniles in black pants came up to the car and began knocking on the doors. The conversation escalated to yelling and the two male juveniles on the outside began to kick and

punch the car. The black car quickly left the area west bound on Hillside Drive. The male juveniles chased the car and then left the area.

Both juveniles were taken into custody and transported to the Bensenville Police Department. At 2016 hours, Juvenile BV called his mother Villanueva, Maricella [REDACTED] and was notified he was at PD. At 2020 hours, R/O called Vazquez, Nelly and was notified Juvenile RC was at PD. Juveniles RC and BV were placed into separate juvenile cells.

Randolph, her son Juvenile AB and [REDACTED] arrived at the Bensenville Police Department and were seated in an interview room. [REDACTED] provided a written statement of the above incident. Juvenile AB provided a written statement of the above incident. Randolph provided a written statement of the above incident. Randolph also told R/O that since a prior incident at her house on 08/09/2016, Juvenile RC has continued to come back to try and fight her son Juvenile AB, reference BV 16-7989.

Both Juvenile RC and BV were advised they are no longer allowed on the property at [REDACTED]. Both RC and BV stated that they understood the trespass warning and would not return to the address.

At 2125 hours, R/O spoke with DuPage County States Attorney Mandy Meindl who recommended Juvenile RC and BV be processed for misdemeanor criminal damage to motor vehicle and be petitioned to juvenile court.

Juveniles RC and BV were processed for misdemeanor criminal damage to motor vehicle and petitioned to juvenile court. At 2214 hours, Juvenile BV was released to mother Villanueva, Maricella. At 2238 hours, Juvenile RC was released to mother Vazquez, Nelly. While speaking with Vazquez, she inquired what her son had done. Juvenile RC explained to his mother what had happened and why he had gotten arrested. Juvenile RC stated "Brian had brass knuckles and was hitting someone's car."

Photographs of the damage to the car and written statements were submitted into evidence and are attached to this report.

Case referred to detectives and petition to be filed for juvenile court.
