These are all of the documents that can be discovered responsive to your request.


Section 7(1)(b) of FOIA provided that "private information" is exempt from disclosure. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when complied without possibility of attribution to any person." 5ILCS 140/2(c-5). Consequently, certain unique identifiers have been redacted from the records being provided.

Section 7(1)(c) of FOIA provides that, "[p]ersonal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion per person privacy" is exempt from disclosure. Consequently, a birthdate and other personal information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy, including a victim's name and identifying information, and the race of an individual, have been redacted from the records being provided.

Pursuant to Section 9 of the FOIA, 5 ILCS 140/9, I am required to advise you that I, the undersigned Freedom of Information Officer, reviewed and in consultation with an attorney for the Village, made the foregoing determination to deny a portion of your FOIA Request as indicated. Should you believe that this Response constitutes an improper denial of your request, you may appeal such by filing a request for review within sixty (60) days of the date of this letter with the Public Access Counselor of the Illinois Attorney General's Office, Public Access Bureau, 500 South Second Street, Springfield, Illinois 62706; telephone 1-887-299-FOIA; e-mail: publicaccess@atg.state.il.us. You may also have a right of judicial review of the denial under Section 11 of FOIA, 5 ILCS 140/11.

Report Narrative ON 06-29-16 AT APPROXIMATELY 0605 HRS, R/O WAS SUMMONED TO THE AREA OF [REDACTED] FOR A REPORT OF CHECK WELL BEING. PRIOR TO ARRIVAL R/O WAS ADVISED BY DISPATCH THAT A SUBJECT (JENKINS, MICHAEL J) KILLED HIS WIFE (JENKINS, TANYA.L) & THEN KILLED HIMSELF. ALL THIS INFORMATION WAS POSTED ON FACEBOOK WHICH CAUSED THE CALLER : LAFFERTY, TOM TO CONTACT THIS PD.

R/O OBSERVED THE RESIDENCE WAS A TWO STORY HOME WITH ATTACHED DOUBLE GARAGE WITH A MAIN DOOR ON THE WEST SIDE OF THE HOUSE & A SIDE DOOR ON THE EAST SIDE. THE WEATHER CONDITIONS WERE DAYLIGHT WITH CLEAR SKIES.

UPON ARRIVAL R/O AND A R/O'S (SGT.HERMES, OFC.NAVARRO, OFC.CHA, OFC.GREICO) SET UP A PERIMETER & BEGAN CHECKING DOORS & WINDOWS OF THE RESIDENCE. OFC.NAVARRO OBSERVED & LOCATED WHAT APPEARED TO BE TWO BULLET HOLES IN THE WINDOW ON THE WEST SIDE OF THE HOME. SGT. HERMES ADVISED THIS PD THAT THE WEST DOOR WAS OPEN & THAT ENTRY WAS BEING MADE.

UPON ENTRY THE TEAM CLEARED THE FIRST FLOOR & GARAGE AND PROCEEDED TO MOVE UP THE STAIRS TOWARD THE BEDROOMS. WHILE WALKING UP THE STAIRS SGT. HERMES OBSERVED BLOOD ON THE STAIRS.

SGT. HERMES AND R/O MADE ENTRY INTO THE WEST BEDROOM ON THE RIGHT & OFC.NAVARRO MADE ENTRY INTO THE EAST BEDROOM ON THE LEFT. IN THE WEST BEDROOM R/O OBSERVED TWO SUBJECTS (ONE MALE WHITE, ONE FEMALE WHITE) LAYING IN THE BED WITH THEIR HEADS UPON THE PILLOWS. THE BED WAS PLACED IN A NORTH/SOUTH DIRECTION WITH THE PILLOWS AT THE SOUTH END OF THE BED. THE HEADBOARD OF THE BED WAS UP AGAINST THE SOUTH WALL OF THE BEDROOM. THE TEMPERATURE WITHIN THE BEDROOM WAS SOMEWHAT COOL.

THE BEDROOM WAS GENERALLY IN A WELL KEPT CONDITION. SGT. HERMES IMMEDIATELY APPROACHED THE FEMALE SUBJECT TO DETERMINE IF ANY SIGNS OF LIFE WERE PRESENT. THE MALE SUBJECT APPEARED TO HAVE A SINGLE GUNSHOT WOUND TO THE FACE CAUSING THE SKULL TO HAVE BEEN OPENED AT THE TOP OF THE HEAD. THERE WAS A LARGE POOL OF BLOOD UPON THE PILLOW TO THE RIGHT SIDE OF THE MALE SUBJECT. THE MALE SUBJECT WAS LAYING ON HIS BACK FACING THE CEILING. THE MALE SUBJECT WAS WEARING A T-SHIRT AND SHORTS. THE FEMALE SUBJECT APPEARED TO HAVE A SINGLE GUN SHOT WOUND TO THE FACE. THE FEMALE SUBJECT WAS FACING EAST ON THE BED, LAYING ON HER RIGHT SIDE. THE FEMALE SUBJECT WAS CLOTHED IN WHAT APPEARED TO BE A ONE PIECE NIGHTGOWN. THE FEMALE WAS COVERED WITH A BLANKET. THE BLANKET WAS NOT DISTURBED BY POLICE.

A BLACK SEMI-AUTOMATIC HANDGUN WAS OBSERVED LAYING ON THE MALE SUBJECT'S CHEST. A HANDWRITTEN NOTE WAS ALSO OBSERVED UPON THE NORTH END OF THE BED BY THE FEET ON TOP OF THE BLANKET. THERE WERE TWO NIGHTSTANDS ON EITHER SIDE OF THE BED, ONE AT THE WEST SIDE OF THE BED WITH ANOTHER PLACED AT THE EAST SIDE OF THE BED, BOTH ALONGSIDE THE HEADBOARD. THERE WAS A CELLULAR TELEPHONE HANGING FROM THE WEST SIDE NIGHTSTAND BY WHAT APPEARED TO BE A CHARGING CORD. THE CELL PHONE WAS ATTACHED TO THE CHARGING CORD.

THE CELL PHONE WAS SOUNDING AN ALARM. IT APPEARED THAT THE ALARM WAS SET FOR 0632 HOURS. THERE WAS AN ADDITIONAL CELLULAR TELEPHONE HANGING FROM THE EAST SIDE NIGHTSTAND BY WHAT APPEARED TO BE A CHARGING CORD. THE CELL PHONE WAS BEEPING INDICATING THAT THERE WERE CALLS AWAITING AND OR TEXT MESSAGES WERE AWAITING. NEITHER CELLULAR TELEPHONES WERE DISTURBED BY POLICE.

ENTRY TEAM EXITED THE BEDROOM & OBSERVED SEVERAL SEALED ENVELOPES ON THE KITCHEN COUNTER ADDRESSED TO VARIOUS PEOPLE TO INCLUDE ANOTHER HANDWRITTEN NOTE. A PURSE, WITH A DL FOR THE FEMALE INSIDE THE PURSE, WAS LOCATED ON THE KITCHEN COUNTER AS WELL. THE IDENTIFICATION FOUND WITHIN THE

PURSE APPEARED TO BE THAT OF THE FEMALE VICTIM, JENKINS, TANYA, L.

A WHITE MERCEDES WAS LOCATED IN THE GARAGE () AND A SECOND VEHICLE WAS LOCATED, A JEEP, (NO-REG AVAILABLE)

BASED OFF OF THE LAST FACEBOOK POST BY MICHAEL, HE WAS INFORMED HIS WIFE (TANYA) WAS HAVING AN AFFAIR & BY A CO-WORKER OF TANYA'S. MICHAEL OBSERVED TANYA AND A MALE SUBJECT (YET TO BE NAMED OR IDENTIFIED) GET INTO AN UNDISCLOSED VEHICLE AND DRIVE BACK TO THE RESIDENCE LOCATED AT AT WHICH TIME THEY WERE OBSERVED BY MICHAEL WALKING INTO THE RESIDENCE & TURNING ON THE BEDROOM AND BATHROOM LIGHTS.

BASED OFF THE LAST FACEBOOK POST, MICHAEL WAITED TO GO INSIDE AND EVENTUALLY WENT INSIDE AND OBTAINED A HANDGUN (AT THIS TIME BELIEVED TO BE A 40.CAL BASED OFF HIS STATEMENT) AND ZIP STRIPS AND THEN WENT INTO THE BEDROOM.

BASED OFF THE LAST FACEBOOK POST, MICHAEL OBSERVED TANYA WITH THE UNIDENTIFIED MALE HAVING SEX. AT THIS TIME HE HAD TANYA ZIP CUFF THE MALE SUBJECT'S HANDS & FEET & HAD TANYA ZIP TIE HER FEET. AT THIS POINT MICHAEL SHOT TANYA ONE TIME IN THE FACE.

BASED OFF THE LAST FACEBOOK POST, MICHAEL THEN TOOK THE MALE SUBJECT TO A UNDISCLOSED LOCATION WHERE HE SHOT THE MALE SUBJECT ONCE IN THE GROIN AREA & ONCE IN THE HEAD. MICHAEL THEN BURIED THE SUBJECT IN A PILE OF ROCKS.

BASED OFF THE LAST FACEBOOK POST, MICHAEL RETURNED TO THIS LOCATION AND WROTE THE LETTERS & THEN SHOT HIMSELF ONE TIME IN THE FACE WITH HIS FINAL RESTING PLACE THAT OF THE BED WITHIN THE UPSTAIRS BEDROOM OF THE RESIDENCE ALONGSIDE THE FEMALE SUBJECT BELIEVED TO BE THAT OF TANYA JENKINS.

Report Narrative: The following is a summary.
On 06-29-16 at approximately 0605 hours, R/S heard dispatch advise of a check for well being due to a facebook post of murder suicide at [REDACTED]. R/S arrived on scene, and did not enter the residence. Officers Stephens, Cha, Navarro, Grieco, and Sergeant Hermes were already searching the residence when R/S arrived. R/S stayed on [REDACTED], on the North side of [REDACTED]. Sgt Hermes advised there were 2 subjects deceased in the residence. R/S held perimeter on the North side of the residence. R/S was approached by several neighbors, and all information was immediately forwarded to the detectives. R/S gained the following information:

Mike Fitzpatrick works for the corporate office of US Foods with Tanya. Tanya did not show up to work today, and he came to the neighborhood to find out why she was not answering her phone. Fitzpatrick advised he previously lived in Bensenville, and was familiar to the town. Fitzpatrick advised he had been to Tanya's home in the past to help her at her home. Fitzpatrick stated Tanya was his supervisor. Tanya's supervisor is Sylvia Wulf. Wulf oversees approximately 80 employees. Fitzpatrick notified Wulf that Tanya is believed to be deceased. (R/S advised Fitzpatrick that the case was under investigation, and the body has not been positively identified. It is believed that the body is the resident of the home.) (Field notes were provided to Sergeant Oliva, whom transferred the information to Sergeant Zodrow.)

Joanna of [REDACTED] advised she has security cameras which face the street. She advised the quality of the recordings would not be able to view license plates, but do capture vehicle descriptions. Joanna stated the detectives may call her for further assistance from the video cameras. Joanna did not hear or see anything during the night or the previous evening.

Richard L Ardisana m/w [REDACTED] stated he did not see or hear anything last night. Ardisana wanted to report that at approximately 6AM this morning he saw a black Mitsubishi with an older male white driver was driving slowly down the street.

Andrea P Soupous f/w [REDACTED] stated a detective spoke to her earlier. She wanted to report that she now believes the noise she heard last night was gun shots. She stated that her back patio door was open. At approximately 930 PM (2130 hrs) she heard a loud noise. She dismissed it as thunder or fire crackers. She said now that hse is thinking about it, it sounded like a gun. She believed someone was doing target shooting because the bangs were distinctive and separate. She estimates that she heard 4-5 shots.

Nothing further at this time.

Report Narrative: **On 7-19-16, Det. Ptak submitted Sexual Assault Kit previously collected from Tanya Jenkins at her post mortem examination to the DuPage County Crime Laboratory.**

On 07-27-16 R/I received Forensic Biology Testing Report, 16-00972-1, from the DuPage County Crime Laboratory. Said report revealed no semen identified but the DNA Section of the DuPage County Laboratory would be further examining Tanya Jenkins vaginal swabs for DNA. Vaginal swabs were recovered from Tanya Jenkins at her postmortem exam.

**On 08-21-16, R/I received DNA Testing Report, 16-00972-2, which revealed a partial Y STR DNA profile. Lab requesting standards from suitable suspect(s) at this time.
