These are all of the documents that can be discovered responsive to your request.


Section 7(1)(b) of FOIA provided that "private information" is exempt from disclosure. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when complied without possibility of attribution to any person." 5ILCS 140/2(c-5). Consequently, certain unique identifiers have been redacted from the records being provided.

Section 7(1)(c) of FOIA provides that, "[p]ersonal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion per person privacy" is exempt from disclosure. Consequently, a birthdate and other personal information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy, including a victim's name and identifying information, and the race of an individual, have been redacted from the records being provided.

Pursuant to Section 9 of the FOIA, 5 ILCS 140/9, I am required to advise you that I, the undersigned Freedom of Information Officer, reviewed and in consultation with an attorney for the Village, made the foregoing determination to deny a portion of your FOIA Request as indicated. Should you believe that this Response constitutes an improper denial of your request, you may appeal such by filing a request for review within sixty (60) days of the date of this letter with the Public Access Counselor of the Illinois Attorney General's Office, Public Access Bureau, 500 South Second Street, Springfield, Illinois 62706; telephone 1-887-299-FOIA; e-mail: publicaccess@atg.state.il.us. You may also have a right of judicial review of the denial under Section 11 of FOIA, 5 ILCS 140/11.

Report Narrative **ON 02-08-11 AT APPROXIMATELY 2320 HOURS, THE R/O RECEIVED A REPORT OF A POSSIBLE PHYSICAL DOMESTIC IN PROGRESS AT [REDACTED]. THE R/O ARRIVED ON SCENE AND OBSERVED 2 M/H ARGUING IN THE STREET. A EXPUNGED, LATER IDENTIFIED AS EXPUNGED, WEARING BLACK SWEAT PANTS, BROWN WORK BOOTS, AND A RED TANG-TOP APPROACHED THE R/O STATING, "THIS FUCKIN GUY IS FUCKIN CRAZY, MAN.....FUCKIN CRAZY". THE R/O OBSERVED A SECOND M/H, LATER IDENTIFIED AS GARCIA, JUAN G M/H [REDACTED], WEARING BLUE WORK PANTS, A RED JACKET, AND HOLDING A CELL PHONE AND ASKING THE R/O TO PLEASE HELP HIM AND HIS NIECE. A F/H APPROACHED THE R/O, LATER IDENTIFIED AS NEGRETE, SANDRA F/H [REDACTED], AND ASKED THE R/O IF WE COULD GO BACK INTO THE HOUSE BECAUSE SHE HAS (2) CHILDREN SLEEPING. EXPUNGED AND GARCIA CONTINUED ARGUING VERBALLY IN SPANISH.**

OFC KOTLEWSKI 561 AND OFC LINKOWSKI 520 ARRIVED ON SCENE.

THE R/O SEPARATED THE PARTIES. OFC LINKOWSKI 520 REMAINED OUTSIDE WITH GARCIA, WHILE THE R/O DIRECTED EXPUNGED AND NEGRETE BACK INTO THE RESIDENCE AT THE AFOREMENTIONED ADDRESS. ONCE IN THE RESIDENCE THE R/O ASKED NEGRETE WHAT HAPPENED. NEGRETE STATED IN SUMMARY THAT, HER EXPUNGED HAD BEEN BEATING HER OVER THE PAST FEW YEARS AND SHE WAS JUST TRYING TO GO TO HER GRANDMOTHERS HOUSE TONIGHT AND EXPUNGED WOULD NOT LET HER LEAVE. NEGRETE STATED THAT SHE ANDEXPUNGED HAD BEEN ARGUING THAT EVENING AND SHE WAS GOING TO GO TO HER GRANDMOTHERS HOUSE, BUT EXPUNGED WOULD NOT MOVE EXPUNGED TRUCK PARKED IN THE DRIVEWAY SO SHE COULD NOT LEAVE. NEGRETE THEN STATED THAT SHE CALLED HER UNCLE (GARCIA) TO COME GET HER AND TAKE HER TO HER GRANDMOTHERS. NEGRETE THEN STATED THAT EXPUNGED GRABBED HER BY THE RIGHT ARM AND STARTED SHAKING HER TRYING TO GET HER PURSE OFF HER ARM. EXPUNGED GOT THE PURSE OFF NEGRETE'S ARM AND EXPUNGED THEN TOOK HER CAR KEYS, PURSE, DL, CELL PHONE AND PLACED THE ITEMS IN EXPUNGED TRUCK. NEGRETE THEN STATED THAT WHILE EXPUNGED WAS GRABBING HER ARMS AND SHAKING HER, GARCIA HAD ARRIVED AND WAS OUTSIDE THE KITCHEN WINDOW LOOKING IN. GARCIA SAW EXPUNGED GRAB NEGRETE'S ARMS AND SHAKE HER AROUND, AT WHICH TIME GARCIA CAME IN THE HOUSE AND ATTEMPTED TO GET EXPUNGED TO RELEASE NEGRETE. EXPUNGED THEN REACHED FOR THE THROAT OF GARCIA, WHICH GARCIA BLOCKED. NEGRETE STATED THAT SHE TRIED TO GET BETWEEN HER EXPUNGED UNCLE, BUT EXPUNGED THREW HER TO THE GROUND AT WHICH TIME SHE CUT HER RIGHT KNEE. THE R/O OBSERVED A 1/2" ABRASION ON THE RIGHT KNEE OF NEGRETE. NEGRETE THEN STATED THAT EXPUNGED PUSHED GARCIA IN THE CHEST CAUSING HIM TO FALL OVER A KITCHEN TABLE CHAIR. GARCIA THEN CALLED 911 AND EXPUNGED FLED THE RESIDENCE. EXPUNGED ATTEMPTED TO PULL EXPUNGED TRUCK FROM THE DRIVEWAY, HOWEVER DUE TO GARCIA'S VEHICLE IN THE DRIVEWAY AND 3FT BANKS OF SNOW LINING THE DRIVEWAY, EXPUNGED BACKED EXPUNGED TRUCK INTO A 3 FT SNOW BANK RENDERING THE VEHICLE INOPERABLE.

THE R/O ASKED EXPUNGED WHAT HAD HAPPENED. EXPUNGED STATED, "MAN FUCK THAT BITCH, HE COMES IN MY HOUSE....SHE'S CHEATING". THE R/O ADVISED EXPUNGED THAT EXPUNGED WAS UNDER ARREST FOR DOMESTIC BATTERY. THE R/O HANDCUFFED EXPUNGED, ENSURING THE DOUBLE LOCK WAS ENGAGED, AND PLACE EXPUNGED IN THE REAR SEAT OF SQUAD #305.

THE R/O SPOKE WITH GARCIA AND ASKED HIM WHAT HAD HAPPENED. GARCIA STATED IN SUMMARY THAT, HE WAS CALLED OVER TO HIS NIECES HOME TO PICK HER UP, BECAUSE HER EXPUNGED WOULD NOT LET HER LEAVE. GARCIA STATED THAT NEGRETE SOUNDED UPSET HE HE HURRIED OVER AND ONCE HE GOT TO THE RESIDENCE AT [REDACTED] HE SAW EXPUNGED THROUGH THE KITCHEN WINDOW ATTACKING NEGRETE. GARCIA STATED IT LOOKED AS IF EXPUNGED WAS GRABBING NEGRETE'S ARMS AND SHAKING HER. GARCIA THEN STATED THAT HE ENTERED THE

HOUSE THROUGH THE KITCHEN DOOR AND TOLDEXPUNGED TO TAKE EXPUNGED HANDS OFF NEGRETE. GARCIA STATED THAT EXPUNGED CAME AT HIS THROAT BUT HE BLOCKED THE ATTACK. GARCIA THEN STATED EXPUNGED PUSHED NEGRETE TO THE GROUND BECAUSE SHE WAS TRYING TO GET EXPUNGED OFF HIM. EXPUNGED THEN TURNED BACK TO GARCIA AND KNOCKED HIM OVER A CHAIR. THE R/O OBSERVED (2) RECENT RED MARKS AND SCUFFED SKIN ON THE LOWER BACK OF GARCIA. GARCIA THEN STATED THAT AFTER HE HIT THE GROUND HE GOT HIS PHONE AND CALLED BPD. EXPUNGED SAW THIS AND TRIED TO LEAVE. EXPUNGED ATTEMPTED TO BACK EXPUNGED TRUCK OUT OF THE DRIVEWAY BUT GARCIA'S VEHICLE WAS BLOCKING MOST OF IT, SO DESPERATE TO GET AWAY, EXPUNGED RAMMED EXPUNGED TRUCK INTO A 3FT SNOW BANK AND GOT EXPUNGED TRUCK COMPLETELY STUCK.

NEGRETE PROVIDED A WRITTEN STATEMENT TO OFC KOTLEWSKI 561.

THE R/O DOCUMENTED THE CONDITION OF KITCHEN CHAIR, THE VICTIM GARCIA, THE VICTIM NEGRETE, AND THE TRUCK STUCK IN THE SNOW BANK BY MEANS OF PHOTOGRAPHING. THE KITCHEN HAD THE APPEARANCE THAT A PHYSICAL ALTERCATION HAD JUST TAKEN PLACE. THE R/O ADVISED NEGRETE THAT EXPUNGED WAS UNDER ARREST FOR DOMESTIC BATTERY AND BRIEF HER ABOUT BOND RESTRICTIONS, AND THE 72 HOURS STAY AWAY PERIOD. NEGRETE THEN INFORMED THE R/O THAT EXPUNGED HAD BEEN ARRESTED FOR DOMESTIC VIOLENCE ONCE BEFORE IN BENSENVILLE, REFERENCE REPORT BV08-22758. NEGRETE THEN PROVIDED THE R/O WITH A DIGITAL RECORDING DEVICE- RCA SN#CGAOEL465A3136. NEGRETE STATED THE RECORDING WAS THAT OF HER EXPUNGED CONVEYING TO A FRIEND HOW EXPUNGED ENJOYED BEATINGEXPUNGED TO KEEP HER "IN LINE". NEGRETE ALSO STATED THAT EXPUNGED ADMITTED TO STEALING PROPERTY FROM HIS CURRENT EMPLOYER AND SELLING THE PROPERTY FOR CASH. THE R/O PLAYED THE AUDIO RECORDING, HOWEVER COULD NOT UNDERSTAND IT DUE TO LANGUAGE BARRIERS. NEGRETE THEN STATED THAT EXPUNGED USES (2) SSN (SOCIAL SECURITY NUMBERS)- ONE FOR WORKING AT HIS CURRENT JOB AND HE USES HIS FATHER SSN FOR HIS SUMMER JOB. NEGRETE STATED THAT EXPUNGED USES EXPUNGED SSN DURING THE SUMMER SO DURING THE MONTHS WHERE THE WEATHER IS TOO BAD TO WORK OUTSIDE CONSTRUCTION, EXPUNGED COLLECTS UNEMPLOYMENT ON A FALSE SSN. THE R/O ADVISED NEGRETE TO COLLECT ANY DOCUMENTATION THAT WOULD SUPPORT HER CLAIM AND PRESENT IT TO THIS DEPARTMENT.

THE R/O PROVIDED NEGRETE WITH A COPY OF THE IL DOMESTIC VIOLENCE ACT VICTIM INFORMATION SHEET. THE R/O ADVISED NEGRETE TO SEEK AN OOP (ORDER OF PROTECTION) IF SHE FEARED FOR HER OR HER CHILDREN SAFETY.

THE R/O TRANSPORTED EXPUNGED BACK TO THE BPD, WHERE EXPUNGED WAS PROCESSED FOR DOMESTIC BATTERY 2X AND BATTERY DCN-L5286546 AND PLACED INTO CELL 3 TO AWAIT COMPLAINTS AND TRANSFER TO DPCJ.

ON 02-09-11 AT APPROXIMATELY 0312 HOURS, THE R/O CONTACTED FAMILY ADVOCACY AND SPOKE WITH LASANDRA. THE R/O PROVIDED ALL PERTINENT INFORMATION REGARDING THE INCIDENT.

ON 02-09-11 AT APPROXIMATELY 0600 HOURS, EXPUNGED WAS SERVED WITH A (3) COUNT COMPLAINT DOMESTIC BATTERY 2X AND BATTERY COMPLAINT # [REDACTED]
