Construction Work will be taking place in the vicinity of your home during the day tomorrow. The hours of construction operation will be between 7:00 am and 7:00 pm. Site conditions, weather, or nature of the work may necessitate occasional periods of work longer than the hours listed.

The work to take place at this time consists of:

Weather pending on 9/14/17 at 9:00am the Village of Bensenville Public Works Department will shut off your water so that new water main can be installed in the Church Road and East Wood Street intersection. We expect that this work will take most of the day and your water will be turned back on by 4:00pm on 9/14/17.

Every effort will be made to allow you access to your property during the course of this work. There will be short periods of time where access will be difficult or restricted. If use of your vehicle(s) is anticipated during these hours, please have it relocated prior to start of work. We will do the best we can to restore the access by the end of each work day. Should you require immediate access to or egress from your property from a temporarily blocked driveway for special circumstances or for an emergency situation, please communicate with the resident engineer on site and access will be granted as quickly as possible.

Effective immediately the Utilities Division has issued this advisory due an emergency water main break in your area. The customers affected are noted below:

The Utility Division has submitted a water sample for Bacteriological testing and is waiting for confirmation the water quality in this area is safe for drinking. This **Precautionary Boil Advisory** is expected to remain in effect until bacteria tests are completed which usually takes between 24 and 36 hours to get the results submitted back to us. Once we receive the “ALL CLEAR” we will notify again by notice.

If more tests are required from our certified laboratory, Village personnel will notify you to extend the boil advisory.

Water used for drinking, food preparation, washing dishes or brushing teeth must be boiled. Water for these purposes should be brought to a rolling boil for a minimum of 5 minutes.
