**CALL TO ORDER:** The meeting was called to order at 7:05 p.m.

**Public Hearing:** CDC Case Number 2011-03  
**Petitioner:** Roesch Ford  
**Location:** 333 W. Grand Avenue  
**Request:** Planned Unit Development to allow three pole signs

The Public Hearing was opened at 7:12 p.m. Dan Roesch was present and sworn in on behalf of Roesch Ford. Mr. Roesch gave a brief history of the company and stated that the new Roesch Ford has been very successful since the move from Elmhurst. Mr. Roesch stated that the current sign ordinance in the Village of Bensenville puts his business at a disadvantage to other dealerships along Grand Avenue. Roesch Ford currently owns the signs at the old Elmhurst Ford location and would like to move them to the Bensenville location. The signs consist of the following, a Ford blue oval sign that will be located in the middle of the property and will be landscaped and stands 42 feet tall, another sign that reads "Ford Used" that will be located on at the east entrance that is 19-3/4 feet tall, and a sign that reads "Ford Trucks" that will be located on the corner of Church Road and Grand Avenue. Commissioner Rowe asked if the Ford oval sign can be lowered to 35 feet. Mr. Roesch stated he was unable to contact the proper personnel regarding the issue. Mr. Roesch stated he will seek an answer to the question. If it is possible, Mr. Roesch stated he was willing to lower the sign to 35 feet. There was no public comment.

**Public Hearing:** CDC Case Number 2011-05

**Petitioner:** Village of Bensenville

**Request:** Text Amendment to Section 10-7D-3 to allow I-2 Light Industrial Uses in the C-4 Regional Destination Commercial PUD District as Conditional Use

The Public Hearing was opened at 7:26 p.m. Scott Viger, Director of Community & Economic Development for the Village of Bensenville was sworn in by Chairman Pro Tem Moruzzi. Mr. Viger gave stated the Village Code was changed in 2005 to allow C-4 uses along North York Road. The Village Boards intentions at the time were to establish business that would become a gateway to the Village. Mr. Viger stated that with the uncertainty of O'Hare Airport and the Elgin/Western By-Pass, businesses were not willing to invest in the locations and the properties began to become vacant. Some property owners continue to express interest for I-2 use but lack similar interest for C-4 uses at this time. The Village has proposed the text amendment to keep the buildings zoned as C-4 but allow I-2 use by conditional use permit only for ten years with an additional two years if approved. This will allow the Village to gain better knowledge of the Elgin/Western By-Pass and O'Hare Airport. Staff recommends approval.

Public Comment:

**Stella Weldon**

Ms. Weldon was sworn in by Chairman Pro Tem Moruzzi. Ms. Weldon stated she was in support of the proposed text amendment but questioned what will happen after the ten years. She will still own the property and be liable for paying taxes. She would like to see the properties be rezoned to allow I-2 uses at all times.

**Frank Favuzzi**

Mr. Favuzzi was sworn in by Chairman Pro Tem Moruzzi. Mr. Favuzzi stated he was in full support of Ms. Weldon's comments. He stated he cannot afford the taxes to the property when the property is not being utilized.

The public hearing was closed at 7:40 p.m.

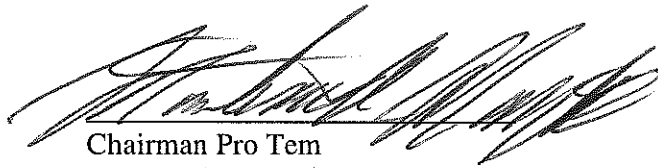
**ADJOURNMENT:**
