I am pleased to help you with your December 28, 2017 Freedom of Information Act ("FOIA"). The Village of Bensenville received your request on December 28, 2017. You requested copies of the items indicated below:

Copy of the last three months of garbage disposal service invoices. Commercial only not residential.
Copy of the companies that submitted RFP or bid for garbage disposal services.
Copy of the last RFP or bid that went out to the public."*

- 1) Attachment C from the Village's Current Service Contract with Republic Services for Service to Municipal Properties. (1 pg.)


These are all of the documents that can be discovered responsive to your request.

In regards to your other requests listed above, the Village does not provide commercial properties with garbage services. They are to do so on their own; therefore, the Village does not have a record of any invoices for commercial services.

The Village of Bensenville first contracted with Republic Services (f/k/a/ BRI and Allied Waste) for Residential Solid Waste, Yard Waster and Recycling services on October 2, 2001. The agreement was extended in 2009 and again in July 2013. The Village no longer has a record of the companies that submitted RFP or bid for garbage disposal services or a Copy of the last RFP or bid that went out to the public.
