## Chicago Department of Aviation Commissioner Visits Bensenville

**Bensenville, IL** – On Friday, April 5, 2019, the Chicago Department of Aviation Commissioner Jamie Rhee toured Bensenville with Village President Frank DeSimone and Village Manager Evan K. Summers.

While on the tour, DeSimone identified some of the Villages most heavily noise-impacted areas like Hillside Drive which experiences over one hundred flyovers per day. They also drove through the industrial district to demonstrate how new businesses are moving to Bensenville specifically for its strategic location of being near O'Hare International Airport while also being located in DuPage County. Some of these include businesses like Zurn and Allmetal Inc which has over one hundred employees in their facility. In addition, they discussed ways to further improve the CDA's property located at the corner of Green Street and York Road.

"Bensenville was thrilled to host Commissioner Rhee to see first-hand the noise impact O'Hare has on our residents," said Village President Frank DeSimone. "As we all know, there is no easy solution to the noise issues plaguing Bensenville.
