These are all the records found responsive to your request.


Section 7(1)(b) of FOIA provided that "private information" is exempt from disclosure. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when complied without possibility of attribution to any person." 5ILCS 140/2(c-5). Consequently, certain unique identifiers have been redacted from the records being provided.

Section 7(1)(c) of FOIA provides that, "[p]ersonal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion per person privacy" is exempt from disclosure. Consequently, a birthdate and other personal information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy, including a victim's name and identifying information, and the race of an individual, have been redacted from the records being provided.

Pursuant to Section 9 of the FOIA, 5 ILCS 140/9, I am required to advise you that I, the undersigned Freedom of Information Officer, reviewed and, made the foregoing determination to deny a portion of your FOIA Request as indicated. Should you believe that this Response constitutes an improper denial of your request, you may appeal such by filing a request for review within sixty (60) days of the date of this letter with the Public Access Counselor of the Illinois Attorney General's Office, Public Access Bureau, 500 South Second Street, Springfield, Illinois 62706; telephone 1-887-299-FOIA; e-mail: publicaccess@atg.state.il.us. You may also have a right of judicial review of the denial under Section 11 of FOIA, 5 ILCS 140/11.

Tim Puralewsky stated the previous tenants did not have cats, and Issac stated they were very clean. They moved to a different building because they wanted to be on the second floor.</p> <p>After they move out the apartment was cleaned and the carpet was cleaned. The carpet was replaced two years ago.</p> <p>Before they rented the apartment to [REDACTED] walked thru the unit to see what he thought. Tim Puralewsky stated he was happy with the apartment [REDACTED].</p> <p>We entered the apartment at approximately 1230pm. [REDACTED] was not present.</p> <p>Entered the apartment and found it to be very clean. There was kitchen, living room and bedroom furniture. There was a bicycle in the bedroom. Did not smell any odor of urine or anything else. It smelled like normal... Nothing looked out of place. Waited a few minutes for [REDACTED] to arrive. Walked out of the apartment at 1240.</p> <p>Met [REDACTED] once we got outside the unit. His first question was if I smelled the cat Urine. I informed I did not smell anything unusual. It smelled fine. He could not believe that.</p> <p>At this time [REDACTED] and Tim Puralewsky began speaking about the unit.</p> <p>Did he want a different apartment. He stated all his stuff contaminated and no longer needed an apartment. He did not want any of the furniture in his apartment because it was contaminated. He told Tim Puralewsky he wants his \$500.00 dollars back, and wants to be reimbursed for all his furniture and clothing. He also wants to be let out of his lease. Tim stated he signed a lease and he was going to give him his \$500.00 dollars back. Tim Puralewsky asked him again he he wanted a different apartment. [REDACTED] stated no. He wants his money back and be left out of the lease. [REDACTED] then took out his phone and showed us pictures of what he said were black light pictures of the urine of the walls and floor of the apartment. He insisted it was cat urine. He said he went on the internet to get all his information on how to locate the urine. He specifically showed</p>

[REDACTED] [REDACTED] did not care he does not want the stuff, it's all contaminated with cat urine. There was more back and forth between Tim Puralewsky and [REDACTED] [REDACTED] then gave the keys back to the Tim Puralewsky and he turned and walked away. [REDACTED] thought about and after a few seconds yelled at Tim asking for the keys back. He stated his lease was not up until March 5th.
