I am pleased to help you with your January 18, 2023 Freedom of Information Act ("FOIA"). The Village of Bensenville received your request on January 18, 2023. You requested copies of the items indicated below:

"Please provide any and all information pertaining to the property located at 435 S Walnut St, Bensenville IL 60106 violations, citations, unpaid balances, permits, prior surveys, lawsuits, lines, etc."

After a search of Village files, the following information was found responsive to your request:

- 1) Village of Bensenville Correction Notice for Inspection No. 94888. (2 pgs.)
- 2) Village of Bensenville Permits Issued to 435 South Walnut Street Since January 1, 2010. (1 pg.)

Please be aware that on February 25, 2014 the Village Board adopted Ordinance No. 16-2014 that requires a Real Estate Transfer Inspection (RETI) be conducted prior to most property sales within Bensenville. You may also have a right of judicial review of the denial under Section 11 of the FOIA, 5 ILCS 140/11.
