I am pleased to help you with your January 20, 2023 Freedom of Information Act ("FOIA"). The Village of Bensenville received your request on January 20, 2023. You requested copies of the items indicated below:

You may also have a right of judicial review of the denial under Section 11 of the FOIA, 5 ILCS 140/11.
